### IMPORTANT :

1. **Vouchers**, as shown in Item G of the Certificate of Candidacy (COC), should be obtained from the immediate head and/or any member of senior management from the place of work. For those who are self-employed, Vouchers may be obtained from any person with moral ascendancy or authority from his/her community, such as Officer of the local community (e.g., Barangay Captain, Town or City Councilor, Vice Mayor or Mayor) or the Parish Priest, Minister/Head of Religious Group.
2. The completely accomplished COC should be accompanied by **two sets of support documents** as follows:
  - (a) xeroxed copy of any valid identification card from any agency of the government, such as passport or Voter's / Driver's / SSS / GSIS ID (i.e., front and back side of the ID) ;
  - (b) xeroxed copy of the latest PRC ID Card (i.e., front and back side of the ID) ;
  - (c) xeroxed copy of the latest PAMET ID Card (i.e., front and back side of the ID); and
  - (d) a recent 2 x 2 colored picture.
3. The completely accomplished COC, accompanied with other pertinent support documents (1<sup>st</sup> set of xeroxed copies), should be **submitted personally to the PAMET Office** not later than **November 5, 2010, Friday, 3 P.M.** in a **sealed envelope**.

Original copies of the required support documents must be presented to the PAMET Office for verification and acknowledgment, together with the 2<sup>nd</sup> set of xeroxed copies of support documents. The 2<sup>nd</sup> set of xeroxed copies are attached to the sealed envelope and also serves as the receiving copy for the Certificate of Candidacy.

**Incomplete COC** (i.e., improperly accomplished or do not have the required support documents) will **automatically be invalidated**.

4. The COMELEC will prepare a summarized information sheet on all qualified candidates to be posted in –
  - (a) the website one week before the Election; and
  - (b) in the designated areas in the convention venue starting November 30, 2010.
5. Qualified Candidates shall strictly refrain from giving out campaign materials nor to engage in electioneering activity in whatever form on the day of the Election, December 1, 2010.
